Director's Reflections on the Year

2024 marked the third year of the full-scale war. Based in Lviv, we are acutely aware of our responsibility to be efficient and impactful while operating far from the front lines and under the protection of Ukraine's Defence Forces.

The past year was one of **institutional maturity for PPV** – we continued developing and implementing our system for tracking project results and impact, expanded our team, and enhanced the expertise of PPV team members. We remained committed to supporting the systemic development and long-term growth of the businesses we advise (PPV has been continuously working with 16 companies), implementing the policies and strategies we help shape, scaling policy tools and formats (models, methodologies, concepts), and fostering the growth of institutions, networks, communities, partnerships, and coalitions we have helped initiate.

For the first time, we actively implemented major direct-contracting projects with the European Commission.

The RES-POL project (Rapid Expert Support for Culture and Media Policies in Ukraine) became our largest project in 2024, involving over 50

external experts. RES-POL was the first comprehensive project supporting the capacity of the Ministry of Culture and Strategic Communications in developing policies in the fields of art, cultural heritage, creative industries, and media. The project contributed to the development of Ukraine's Culture Development Strategy until 2030, approved by the Cabinet of Ministers of Ukraine in March 2025. Building on our experience with the Clean Baltic Source project, implemented in 2023-2024 with the support of the Swedish Institute, we prepared and received approval for a large-scale (€1 million) project under the LIFE programme to strengthen Ukraine's water supply and wastewater sectors. In 2024, we also signed a new edition of the ReHERIT project (Common Responsibility for Shared Heritage).

In total, we implemented 44 projects in 2024 and continued working with 16 businesses we've supported over the years through various consulting engagements. This year, PPV has launched a grant support service for businesses and business support organizations.

The PPV team continues contributing to Ukraine's economic development, and we invite you to explore the story we created in 2024.



Ukraine urgently needs mature businesses, reformed public systems, and new institutions at every level – from local communities to the national level. Often invisible, PPV's work is vital to Ukraine's economic development. Last year, we constantly reminded ourselves to ask: are we doing enough for our future? War intensifies our sense of responsibility – and I am grateful to the entire PPV team, our clients, and partners for embracing this shared responsibility.

SME Development and Business Maturity

Supporting the development of small and medium-sized enterprises has been a core priority for PPV since our founding in 2008.

Year after year, our team invests significant effort to help Ukrainian businesses grow. We assist in developing and adapting business strategies, building management systems, supporting the preparation of project and investment proposals, facilitating innovation, encouraging smart scaling, and conducting analytical research.

These services have proven especially vital in times of war and growing uncertainty. Through them, we contribute to economic development by helping businesses become resilient, sustainable, and mature.

In 2024, we supported the same number of businesses as in the previous year but provided more consulting, training, and mentoring. This year, a growing number of companies requested strategic sessions and implementation support. We developed and launched a new **grant advisory service** and supported three companies in preparing their project applications. In 2024, the PPV team has also piloted a new service for managerial accounting support, which we plan to actively promote **on the market in 2025**.

New Economy of Ivano-Frankivsk: Supporting Emerging Innovative Economic Activity Clusters in Ivano-Frankivsk

In 2024, within the project <u>New Economy of Ivano-Frankivsk</u>, we conducted a study of the city's innovation ecosystem, organized seminars on innovation management, and developed recommendations for building a robust innovation platform. Together with our partners, we held the 2024 <u>European Research and Innovation Days in Ivano-Frankivsk</u>, which became a space for discussing innovation projects in the fields of product design, sustainable construction, and applied science.

The project's findings were <u>integrated</u> into the <u>development strategy of</u> the <u>Ivano-Frankivsk Territorial Community</u>, to which PPV experts has also contributed in 2024.





Analytical Study of the Business Environment in Mykolaiv

PPV experts conducted a comprehensive analysis of the micro, small, medium, and largebusiness sectors in Mykolaiv Oblast, identifying key challenges and providing recommendations to local authorities and business support organizations. The study covered 500 respondents – representatives from businesses of various sizes and industries, including services, trade, food production, agriculture, and more.

Local Economic Development

We support territorial communities in strengthening and developing local businesses, fostering innovation, and implementing development projects. In 2024, our experts designed economic development models, delivered trainings, seminars, and information sessions, created an online course, and prepared six analytical reports.

U-LEAD Training Course: "Business-Friendly Community – From Challenge to Project Idea"

As experts within the <u>U-LEAD</u> programme, the PPV team developed this online course for community representatives and local government officials responsible for business engagement, investment attraction, and economic development. The course provides practical tools for designing business support and entrepreneurship development projects. It covers concept development, intervention logic, and grant application preparation.

A video case study included in the course highlights the Carpathian Culture Centre – a story of transforming an abandoned carpet workshop into a hub for artisans and entrepreneurs. What began in 2017 is now a vibrant 2,000 m² cultural and economic development initiative. This real-world example offers valuable lessons in effective local economic development, showcasing not just tangible results, but real impact.

Selected Projects

Mariupol 2040 Economic Development Model

The Mariupol 2040 model outlines 10 post-deoccupation recovery scenarios – from transforming the city into a tourism hub to becoming a powerful industrial centre.

PPV experts developed the Mariupol Economic Development Model for the <u>Mariupol Reborn</u> project led by the Mariupol City Council. The model is a practical tool for strategic planning, mobilizing financial resources, and monitoring results.

The Mariupol 2040 model outlines **10 post-deoccupation recovery scenarios** – from transforming the city into a tourism hub to becoming a powerful industrial centre. It combines the city's historical strengths (metallurgy, logistics, machinery) with new promising sectors such as IT, tourism, blue economy, education, and healthcare.

A key feature of the model is its alignment with European strategic planning principles through operational programs and flagship projects. A total of **17 operational programs** are proposed, each corresponding to a specific development sector or economic driver (infrastructure, education, innovation, entrepreneurship, logistics, etc.). These will be implemented via open calls, ensuring transparency, efficiency, and broad engagement from local, national, and international stakeholders.

In addition, 16 flagship projects were identified – large-scale infrastructure or institutional initiatives such as the Mariupol Industrial Park, the Recovery and Development House, the Congress Center, and the Azovstal Memorial Centre. These projects will be coordinated directly by the local government and serve as the foundation for the city's economic transformation.

The model is built on a human-centred, market-based, EU-integrated approach and a comprehensive analysis of the local economic base. It includes an assessment of the pre-war economic structure, identification of key and supporting sectors, analysis of recovery potential, and the formation of new economic directions through entrepreneurship promotion.



"To offer a realistic model for Mariupol's economic development, we went beyond merely restoring the pre-war state. We combined what can be recovered with what has the potential to be transformed. Importantly, this model reflects not just economic calculations, but also the human dimension—the desire of Mariupol residents to return and rebuild their city. We created 10 development scenarios, supported by flagship projects and transparent support tools. This made the model not just an analytical document, but a decision-making tool grounded in the capacity of the community, businesses, and partners."

Institutional Development

Strong institutions are the foundation for economic, community, and national development.

That is why PPV places special emphasis on building capable and effective institutions – and institutional development remains one of our strategic focus areas. One of the most important projects in this focus area is RES-POL. We also organize and deliver trainings, workshops, lectures, and produce online courses for institutions.

Selected Projects

Establishing the "Novo" Business Support Centre

By the end of 2024, the Centre was fully operational and had already provided consultations to 33 local entrepreneurs.

In 2024, we supported the launch of the "Novo" Business Support Centre in the city of Novovolynsk. Together with the Centre's team, we developed an institutional model with clearly defined services, delivery procedures, performance indicators, and scaling potential. We also helped define the annual operational plan, monitoring system, team development plan, and set specific goals and expected outcomes. Additionally, we delivered training sessions for the team on services for SMEs, communication strategy development, and working with entrepreneurs. We also advised them on designing a viable financial model.

RES-POL

In 2024, with the support of the European Union, our team launched a flagship project to shape national policies in the field of culture – developing a cultural development strategy, operational programs, legislative proposals, and conceptual frameworks for potential reforms in Ukraine's cultural sector.

This initiative is called <u>RES-POL</u> – Rapid Expert Support for Culture and Media Policies in Ukraine. The project will run until mid-2025.

RES-POL works closely with the Ministry of Culture and Strategic Communications of Ukraine, which will implement the project outcomes, as well as with the Ukrainian Cultural Foundation, the Ukrainian Book Institute, the State Agency of Ukraine for Arts and Art Education, and cultural leaders driving systemic change.

The project focuses on four key sectors – cultural heritage, arts and culture, creative industries, and media – and addresses 10 critical cultural policy issues identified in collaboration with the Ministry.

In 2024, RES-POL published its first **20 analytical papers**, including briefing notes and baseline reports, which examined key policy questions across sub-sectors, creative industries, and major challenges facing cultural development in Ukraine. All project materials are available on the PPV info portal.

RES-POL has already engaged **1,624 cultural sector stakeholders** through in-depth interviews, focus groups, surveys, newsletters, working meetings, and presentations. Further activities are planned, including sociological research, public presentations, policy dialogues, and more.

At the end of 2024, RES-POL experts actively contributed – alongside the Ministry of Culture and Strategic Communications – to the development of Ukraine's **Culture Development Strategy 2030**, a key structural component of the European Commission's Ukraine Facility initiative.

Grant Management School

In 2024, the PPV Economic Development Agency launched the **Grant Management School** – a hands-on educational program designed to build professional competencies in attracting and managing grant funding. The School is aimed at professionals who already have experience in writing and implementing grant projects and want to deepen their expertise.

Sixteen participants from various Ukrainian cities, including Lviv, Kyiv, and Poltava, successfully completed the program and became its first graduates. They praised the high level of practical relevance, up-to-date content, and the opportunity to exchange knowledge with peers and experts.

Communication

This year, we rethought our visual style and changed the logo of our company. We are entering 2025 with a new branding.
